BY CONSENT AND WITHOUT ADMISSIONS:

In these orders:

"Copyrighted Works" means any and all sound recordings, whether now in existence or later created, of which any Record Company Party (including its parents, subsidiaries, affiliates, or distributed labels) is the owner or exclusive licensee under the Copyright Act 1968 (Cth).

"Kazaa Parties" means the respondents in Proceedings NSD 1809 of 2005 other than the fifth respondent (Philip Morle) and the tenth respondent (Anthony Rose).

"Kazaa System and Software" means the software distributed under the name "Kazaa" or the "Kazaa Media Desktop" or "KMD" or "Kazaa Plus" (the "Kazaa Software"), the computer servers operated by any of the Kazaa Parties, and other activities in which any of the Kazaa Parties engaged, including operating the "kazaa.com" website, to allow users of the Kazaa Software ("Users") to connect to and use computer networks consisting, inter alia, of other users of Kazaa Software, to reproduce and distribute digital files.

"Record Company Party" and "Record Company Parties" means the appellants in Proceedings NSD 1809 of 2005. 46

Proceedings NSD 1809 of 2005

THE COURT 1.

The Court Dotes the undertaking of the fifth respondent, Philip Morle, by himself, his servants and agents in the course of his employment by, or pursuant to his engagement as a consultant or contractor to, any of the Kazaa Parties or any entity or any person involved in the operation, maintenance or supply of the Kazaa System and Software, not to solicit, authorize or induce users of the Kazaa System and Software to reproduce or communicate to the public (whether by making available online or electronically transmitting) any of the Copyrighted Works without the licence of the relevant copyright owner.

- 2. So long as the Fifth Respondent is employed, or engaged as a consultant or contractor to, any of the Kazaa Parties, the Fifth Respondent will be deemed not to be in breach of the undertaking at paragraph 1 above in any circumstance which is not a breach of the orders made on 4 August 2006 in Proceedings No. NSD 1665, NSD 1666, NSD 1667 and NSD 1809 of 2005 by that Kazaa Party for which he is an employee, consultant or contractor.
- 3. Each of the Record Company Parties and the Fifth Respondent bear their own costs in relation to the proceedings at first instance (including any interlocutory orders) and the appeal proceedings and all existing costs orders as between the Record Company Parties and the Fifth Respondent be vacated.

4. The Appeal otherwise be dismissed as against the Fifth Respondent.
